### Club Requirements:

#### Article III Meeting

##### Section 1. Regular Meetings.

A regular meeting of the members shall be held at the principal office or such other place as may be designated by the board of directors on the second Monday of each month. Beginning with the year 1959, at the hour of 7:00 P.M.

Note: One exception to that will be in April, where a conflict with the Spring Game hearing occurs, and the meeting would occur on the first Monday of that month.

Members are required to attend four meeting per year, unless member obtains approval by the board for absences due to work or personal reasons. Failure to meet the four meeting requirement will forfeit said members membership for the following year, and they will have to reapply for admittance into the club. Initiation fees would apply.

#### Article XI Dues

##### Section 1. Annual Dues:

The board of directors may determine from time to time the amount of initiation fee, if any and annual dues payable to the corporation by members of each class.

##### Section 3. Default and Termination of Membership

Membership dues that are payable for the existing fiscal year are required to be paid in full by the first membership meeting of that calendar year. Any member of any class shall be deemed in default of the payment of dues, after the February meeting of that fiscal year or period when such dues became payable. His membership may thereupon be terminated by the board of directors in the manner provided in Article III of these bylaws.
